The foundation provided monetary funds to the Heritage Place long-term care facility for purchase of a bus to transport elderly and disabled residents. Other funds provided throughout the year were used for the purchase of robotic therapy animals, printed materials, and supplies benefiting the residents.

4b (Code:) (Expenses \$ 17,330 including grants of \$ 10,826) (Revenue \$ 39,284)
The foundation supports the activities of several cancer programs in the community, most notably sponsorship of the AK Men's Run to raise awareness for prostate cancer. Support of other programs includes providing yoga instruction and fitness classes to patients receiving care at CPH, headphones and journals for Oncology patients, and Pink Ribbon supplies for the Cancer Care program.

4c (Code:) (Expenses \$ 6,308 including grants of \$) (Revenue \$ 1,971)
The Patient Assistance program provides monetary relief for low-income patients who require transportation, medication, medical equipment, and other services they cannot afford on their own. A total of 87 patients received transportation assistance to or from CPH and 21 patients received assistance for prescriptions, oxygen rentals, airfare, or hotel lodging.
